OVERVIEW

This conference provides Physicians and Healthcare Providers evidence-based research and clinical protocols on new procedures, methods, and topics in Age Management Medicine that will increase competency, knowledge and provide treatment tools that improve patient outcomes and patient satisfaction.

OBJECTIVES

- Understand practical approaches to integrating genomics into clinical workflows
- Develop a comprehensive understanding of what treatments have demonstrated an evidence based effectiveness in treating aging patients and what reversing a biomarker of aging means
- Describe the limitations of single-analyte, reference-range-based lab interpretation and explain why systems-medicine problems require multi-domain integrative analysis and differentiate a single-pass general-purpose AI approach from a structured multi-agent architecture and apply the framework to clinical cases.
- Identify and describe the biological mechanisms and clinical significance of inflammaging as a modifiable driver of aging and age-related decline and Apply IgG glycosylation (GlycanAge) testing and hormone optimization strategies to assess and manage chronic inflammation in longevity medicine.
- Identify and describe the most common causes of hair loss associated with aging and develop an evidence based approach to diagnose and treat age-related hair loss
- Identify the role of imaging exams in evaluating chronic inflammation in the human body. Understand the different types of fat in the body and their characteristics on imaging exams and evaluate for imaging findings related to insulin resistance and metabolic syndrome and describe how to order exams for metabolic disease
- Understand and describe the impact of inflammation on the production of Neurosteroids and the effects of NSAIDs on steroidogenesis
- Describe the current clinical evidence on menopausal hormone therapy in women with treated stage I–II breast cancer, including its impact on recurrence, breast cancer–specific mortality, and overall survival Understand the difference the breast cancer risk profiles of legacy estrogen–progestin regimens versus contemporary approaches using bioidentical 17 β -estradiol and micronized progesterone, incorporating relevant mechanistic insights. Develop an evidence-based, individualized decision-making framework that balances oncologic risk with quality of life, including the potential roles of estradiol, progesterone, and testosterone in carefully selected patients.
- Understand and identify procedures to treat Sexual Health, and consider the best practices for developing a personalized patient treatment plan
- Describe proper intermittent fasting, terms, and expected outcomes and understand types of ketones and proper usages/amounts
- Identify and understand " Functional Indices of Longevity, testing methods and develop evidence based interventions as required
- Identify and understand the mechanisms by which microbiome-based dysbiosis causes endocrinopathy
- Identify and apply a five domain preventive screening framework integrating insulin resistance as the unifying upstream driver and development appropriate evidence based treatment programs
- Understand the science behind the use of CPET testing to assess patients and describe how to use a CPET device to accurately measure function
- Identify the two most human tissues likely to become senescent and the effect of this process if not reduced
- Describe the adipocyte as an endocrine organ and explain how its multi-receptor physiology supports a whole-patient approach to weight and hormonal health and how to apply an integrated clinical framework to obtain sustainable outcomes and preventive care

- Understand the role of the gut in detoxification, articulate 2 mechanisms by which microbiome manipulation can resolve autoimmune disease and allergy, understand the microbiome histamine connection
- Understand and identify how to interpret and integrate 15–20 of the most clinically useful laboratory tests in functional medicine and apply them in a structured diagnostic framework to identify metabolic, endocrine, gastrointestinal, immune, and environmental drivers of chronic disease.
